**** Medicated Bath:** This service is recommended for pets with all types of skin and allergy conditions. Our professionally formulated shampoos soothe and promote healing. Some of these products are available for purchase or can be ordered for you.

**** Hot Oil Treatment:** This treatment is highly recommended for pets with severe dry coat and skin. The product is heated and applied to a wet coat and requires leave-in time. After rinsing and blow drying, the coat will be noticeably healthier and the skin will be supple from emollient absorption.

**** Nail Sculpt:** A process that uses a fine grit stone to shape the nail and eliminate sharp rough edges.

**** De-Shedding:** A process of removing excess undercoat with special tools and products. Reduces shedding in the house and is essential for double coated breeds, it is also great for the skin. Recommended every 3 months.

**** De-Matting:** This removes tangles from the pets' coat, using professional products to loosen them. A great length of time is involved with brushing and combing. Be advised that in severe cases of matting this service is not recommended as it can be very painful, areas of thinning will be evident, and skin irritation may / will occur.

**** Blueberry Facial:** An aroma-therapeutic shampoo used on the face for brightening, whitening, and odor removal.
